NATIONAL SOCIALISM AND SOCIAL RACISM

WHAT IS NATIONAL SOCIALISM?

National Socialism is nature, the application of natural laws to the life of man. In the beginning these laws governed us, but when we created civilizations we were able to omit them, paying a high price for it. National Socialism is therefore a return to the natural social order. It is not a mere political ideology but a religion, a new faith, based on the laws of nature and common sense. Those who are guided by common sense in solving the problems of the contemporary world are National Socialists even if they have not read a page of NS literature. If you would show children the world and tell them how they would order it, you would realize that they are comrades, because all children are guided by their common sense until adults ruin them with their "politically correct" education.

IS NATIONAL SOCIALISM LEFT-WING OR RIGHT-WING?

National Socialism is based on common sense and is not bound to any ideological dogmatism. It applies the correct policy for each given situation and adapts itself to the problems and circumstances that arise in the different epochs.

WHAT DOES ADOLF HITLER MEAN TO YOU?

Adolf Hitler is a spiritual leader, he is not just a political leader or someone who did something good for his country and who we should all imitate in our own country. He lives in our hearts, we just have to listen to his message. When I feel down because of some problem of modern urban life, I just have to take Mein Kampf, concentrate and I can hear his words telling me "there is a place for you, those who hurt you are those who fought me, *don't give up!!! Get up, get up and carry on!!!!*".

WHY IS ADOLF HITLER SO HATED TODAY?

Because the enemies of the Fuhrer, who rule the world today, subjected the white race to a strong brainwashing using the mass media that have perfected their task of indoctrination through movies, radio, educational books, comics, etc., in order to make them hate their racial leader. It was the Fuhrer who tried to return the white race to the path of evolution, hence the reason why they wish to sow hatred towards him to keep the white race on the path of involution.

BUT WHILE HE IS HATED, MANY PEOPLE IDENTIFY WITH HIM, ADMIRE HIM AND EVEN WISH FOR HIS RETURN.

Because despite the brainwashing, whites are beginning to tire of the problems caused by the policies of the "good guys": coloured immigration, rising crime, unemployment, drug addiction, sexual perversion, etc., problems that did not exist in the Third Reich.

Moreover, the Fuhrer's life was a real odyssey, he went through all the hardships that a man can suffer, loss of his parents, destitution, poorly paid jobs and poor conditions and then became the most powerful man in Europe, his life story can serve as inspiration and encouragement to many whites today, even his falling in love with Estefania, (who found out as an old woman that the one who left those letters under her door was the Fuhrer himself) can help a young teenager in a similar situation.

WHAT IS SOCIAL RACISM?

Social racism was put forward by Gaston Amaudruz and the New European Order and consists of a just social order, in other words, a true socialism, which consists of giving everyone what they deserve according to their effort and ability. And racism is natural nationalism, which is not based on territorial boundaries but on race, which has its rules imposed by nature.

IS THERE A DIFFERENCE BETWEEN NATIONAL SOCIALISM AND SOCIAL RACISM?

There is none. Social racism is National Socialism in its highest evolution. National Socialism was born as a German nationalist movement whose definition of German was racial and not merely territorial, remember that the main figures of the movement were not born on German soil, the Fuhrer was born in Austria, Hess in Egypt, Rosemberg in Georgia and Darre in Argentina. They were Germans by race, but they later realized, as Interior Minister Frick rightly stated, that such a German race does not exist; the Germans are a people composed of all the divisions of the white race in different proportions, just like any other people in Europe, and therefore to be a citizen of the Reich one had to be of German or assimilable blood and of course prove by deeds that one was worthy of that distinction, so that citizenship was granted to men on completion of their compulsory military service and to women on marriage. Mein Kampf begins with the most important phrase for the National Socialists: "*peoples of common blood belong to a common fatherland*", which affirms that race is the main concept of the movement and not the nation in which the individual was born.

The Third Reich did not manage to unify the white race due to the defeat suffered by the forces of unnature in 1945, but in spite of this hard blow, thirteen years later in 1958 National Socialism was reborn, this time in the United States of America, in the country that fought the NS the hardest and on the initiative of a soldier who fought against NS Germany: Commander George Lincoln Rockwell. It was not by chance that the NS resurfaced in the USA, in that country there are three factors that determined this phenomenon, the white race is composed of the most varied peoples of Europe, the white race is unified and is threatened by its natural enemies. In those days the dangers were the black man in the streets and the Jew in the economy, today they have been joined by Mexican and Latino gangs. Under these conditions Commander Rockwell, who could see the reality unfolding before his eyes, realized that to save the white race from the danger of colour, the white men of the world must unite and not separate into small homelands under different flags. Rockwell took up National Socialism where it had fallen and expanded its message: the union of the white race, giving his life for this cause. It is with Rockwell that white nationalism or social racism arose, thus both terms National Socialism and social racism are synonymous today.

WHAT DOES THE SECOND WORLD WAR MEAN TO YOU?

The battle between the forces of nature and the forces of unnature. That war is not over yet, unnature has won only one battle, as long as there are those who resist its advance, it will not win.

THE ARYAN STATE

WHAT WILL THE NEW RACIAL STATE LOOK LIKE?

The human races are the nations created by nature; the Aryan white race comprises three types, Nordic, Alpine and Mediterranean. There are those who also add to this classification Dinarics and Eastern Balts. These three or five types, which today do not exist in a pure state practically anywhere in Europe, possess distinct characteristics, the Nordic being the most developed and perfect because of the rigorous climate in which they have been formed. Each European nation has varying degrees of blood from each of these three or five branches of the white race, which generates the particularities of each country. But the fact that we share a common blood makes us related as of the same racial family, and as every family wishes the best for the advancement of its members, we wish the same for our racial kin. Look at this, every white nation competes and brags about the achievements that their nationals produce, for example the space race between the USA and the USSR, all space technology was created by the same race, imagine if instead of competing as "rival" nations we would unite as one nation. The Aryan state has that purpose, to pursue the maximum advancement and development of the race, and I am sure we cannot imagine even a quarter of what we could achieve if we were to unite our forces and capabilities.

The new racial state will embrace all European nations or nations of European blood, in which a common language will be spoken, the other languages being only regional secondary languages. Aryan nationality will be obtained by fulfilling two basic requirements: by belonging to the white race, whose certificate of Aryanity will be issued by the office of racial classification and hygiene, and by proving that one is psychically and physically fit to belong to, defend and honour the new state. Citizenship will only be granted once the individual has completed his or her military and labour service in the case of a man and social service in the case of a woman after marriage. Until then they will be subjects of the state.

Those of non-Aryan Caucasian blood who temporarily reside within the borders of the new state will be considered as guest peoples and will be treated under special regulations.

WHY IS NATIONALITY GRANTED AT THE MOMENT OF MARRIAGE AND NOT AT BIRTH?

Because at marriage the individual has already fulfilled the compulsory tests established by the state and has therefore already undergone a first natural selection, so that only the most physically, mentally and morally fit will be citizens and will be able to procreate.¹

WHAT WILL BE THE FUNCTION OF THE RACIST STATE?

To be the breeder of the race, its aim being the maintenance and progressive ascent of the white people, selecting the best individuals for procreation and keeping out the useless ones, the same function which is performed by the breeder of any race of animals and which in the beginning of mankind was performed by nature.

The state will be responsible for enforcing the law of nature when the white man's inventions lead him away from it. For example, if under nature the struggle to obtain his food kept the white man in good physical condition, now the state will see to it that this training is received in educational institutions.

If the white race conquers a territorial space that provides it with abundant and easily accessible vital resources, the state itself will detect those who survive by circumventing natural law and will apply the corresponding policy to them so that the biological waste does not reproduce and contaminate the whole community. All state law will be a reflection of natural law.

WHAT WILL BE DONE WITH THOSE WHO ARE UNFIT FOR PROCREATION?

If the individual is physically and psychically healthy but possesses a defective genetic load capable of engendering sick individuals, he will be sterilized, this fact will not affect his sexual life in the least and if he decides to do so of his own free will it will be considered a heroic act, in addition he

will have the possibility of adopting a genetically healthy child without parents to give him all his love and educate him to make him a useful member of the community, therefore he will not be deprived of paternity.

If, at that time, genetic engineering means are available to alter defective genes and allow the individual to have healthy offspring, such sterilization will not be necessary.

Dangerous and asocial sick people will be confined and prevented from having even the slightest contact with the community.

IN THIS NEW RACIAL STATE, ARE THERE SOCIAL CLASSES?

Social racism recognises only one social class: the working class. In the Aryan community there are no class antagonisms, all members perform the tasks for which they are best suited, either with their arms or with their brains, and get the remuneration corresponding to their effort and ability. The remuneration will be variable according to the task performed and according to how many members of the community benefit from it. But the variability of remuneration will not create any kind of status, because all activities are indispensable, from the doctor to the sweeper, and all those who contribute to the greatness of the state by working honestly will be guaranteed a dignified life and will possess the prestige of being citizens of the Aryan state.

IS SOCIAL RACISM PROGRESSIVE?

Social racism pursues a return to the natural social order corrupted by the French Revolution. Progressivism (or leftism, which will be explained later) is the decomposition of society through the acceptance of all that is unnatural. The chaos that is today's "progressive" West with its men who become women, women who become men, men who are "women locked in men's bodies", with its culture of approval of abortion, drug addiction, uncontrolled non-white immigration, rights and protection for sub-humans, etc. We owe all this to a little book called "The Social Contract" by Jean Jacques Rousseau, more precisely to its opening sentence "*Men are born free and equal and society perverts them*", therefore we are all free and do what we want and we are equal and therefore we are what we want too.

Social racism comes to reverse this hell and to re-establish with its laws the power of mother nature. It is somewhat paradoxical that in a world where it is progressive to consume natural foods or to carry out natural medical treatments, which we also want, it is completely an aberration to return man to the subordination of natural laws, not to mention the hysteria that progressives would have if there were talk of natural selection in man.

SINCE YOU HAVE ALREADY MENTIONED IT, WHAT DO FEMINISM AND ABORTION RIGHTS MEAN TO SOCIAL RACISM?

Social racism opposes everything that is not a product of nature but a human corruption of its laws. Equality between men and women does not exist in the natural order, both sexes are

different, have different capacities and both carry out the activities for which they were naturally endowed. Feminists are women who want to break their role as such and declare war on men, therefore feminism can only bring tragic consequences for the community.

Regarding abortion, it is an absolutely unnatural fact, since by nature females of all species give their lives to save those of their offspring, the woman who willingly murders her child is a degenerate, therefore in the new order the termination of a pregnancy will only be allowed in case of rape, malformation of the foetus or risk to the life of the mother, for which a judge's order will be required to perform such an intervention. The most precious asset will be the healthy Aryan child, and those who carry out such a procedure illegally, both the doctor who performs it and the woman who has requested it, will be punished with the greatest severity.

WHY WOULD A PREGNANCY BE TERMINATED IN THE CASE OF RAPE?

Because nothing ensures that the child is genetically healthy, it is very likely that the father is mentally weak or affected by defects that the child will inherit.

WHAT ABOUT THE WOMAN'S RIGHT OVER HER BODY?

The foetus is not "her body", she cannot decide on the life of a child, let alone a healthy child. The racist social state has the welfare of children as its priority and if a child is healthy the state will ensure that it can develop its natural faculties to the fullest for the common good regardless of how it was conceived.

Abortion is a great deception, it covers up a genocide on the white population, for it will be the healthy whites who will have abortions while the subhumans will continue to have children either through neglect or to collect welfare or use them as labour.

WOULDN'T FREE ABORTION PREVENT THE BIRTH OF MANY DEFECTIVE INDIVIDUALS?

When Planned Parenthood was founded, its purpose was supposed to be eugenic, i.e. that only abnormal foetuses should be aborted, but these practices were to be left to the free will of the individual without any interference from the state. As the state does not control these surgical interventions, women may resort to them unnecessarily for the sole purpose of getting rid of the unborn child, even if it is perfectly healthy and normal. Whereas moronic individuals may not resort to abortion because of their lack of responsibility due to mental weakness, thus producing the opposite effect to the desired one.

WHAT IS THE ROLE OF THE WOMAN IN THE ARYAN STATE?

To be the mother of the best men and women of the race, her pride lies in seeing her son become a man who will contribute to the advancement of the Aryan community, and her choice of mate is for the purpose of procreating the most genetically perfect child possible. The woman can pursue other activities as long as they do not interfere with her motherhood.

WHAT FOR SOCIAL RACISM IS NATION AND FATHERLAND?

A man's true nation is his race and his true homeland is the land from which his ancestors came, the word itself says, "land of the fathers". The rest are cultural and linguistic entities created by man and as such are subject to change without altering in the least the gene pool that determines the destiny of peoples.

Nationalism or "patriotism", which is the exacerbated love of a piece of land and a particular language and symbols, leads to racial disintegration by dividing and pitting brothers and sisters against each other because they were born in opposing or rival nations, while in this fratricidal struggle they are united with people of other races, since the nationality of contemporary nation states is obtained only by birth or by a simple formality. That is why nationalism divides what should be united and unites what should be divided.

The race being our nation, we love whatever land is inhabited or has been colonized and conquered by white men, for we desire the progress and expansion of our race. And if a white ethnic group or a single white man is wronged, wherever he may be, the whole race is wronged and we are obliged to respond, as the comrades who have heroically left their respective local "homelands" to fight for the white race in Rhodesia and South Africa have heroically done.

HOW DOES THE ARYAN "SUPER-STATE" DIFFER FROM THE MARXIST "SUPER-STATE"?

The Aryan state will embrace peoples of the same race and its aim will be the protection and advancement of the Aryan race, while the Marxist state embraces nations of different races and its only aim is to maintain the domination of its population and for that it needs a people without origins or identity, The best example of this is the so-called "Latin American homeland" which is the union of all the countries of Latin America, which in reality means a massive invasion of coloured immigrants into the white territories of the extreme south of the continent with the consequent progressive disappearance of the Aryan race in the region.

WILL THE NEW RACIAL ARYAN STATE BE LIKE THE FORMER USSR OR YUGOSLAVIA?

No. While the racist social state will embrace all the Aryan nations of the planet, there will not be one nation that prevails over the others as was Russia in the USSR and Serbia in Yugoslavia. Each nation will have an equal position vis-à-vis the others and the state will guarantee the autonomy of each of them, intervening only in strictly necessary cases, such as an attempt at sedition or one nation endangering the stability of the state.

WHAT WILL THE ECONOMY OF THE NEW STATE BE LIKE?

The economy of the new state will be based on the needs of the great Aryan nation. The state will have a monopoly on the printing of money, so that by controlling this resource in accordance with production, inflation will be non-existent. The capital of the nation will be the industriousness of

its citizens. Employment will not be lacking for any member of the nation and wages will ensure a dignified and prosperous life for every productive inhabitant.

The Aryan empire will be the greatest economic superpower ever known to man, bringing together all the technologies, raw materials and labour power of the white world into a single state.

WILL THERE BE SOCIAL WELFARE IN THE NEW STATE?

Only in exceptional situations and only temporarily, the white man only needs opportunities to develop his potential and these will be guaranteed by the state, uncontrolled social assistance only leads to the survival and reproduction of the parasites and the useless.

WHAT CATEGORIES WILL THE INHABITANTS OF THE ARYAN STATE HAVE?

There will be three categories: citizen, subject and guest.

Citizen: every Aryan inhabitant who completes his compulsory military service in the case of a man and his compulsory social service in the case of a woman upon marriage. The granting of citizenship will enable the inhabitant to exercise his political rights and to procreate.

Subject: shall be any Aryan inhabitant who has not yet completed his compulsory military service in the case of a man or social service in the case of a woman, and who has not yet married. They may not exercise political rights as long as they are subjects.

Guest: shall be any inhabitant who for particular or exceptional reasons resides within the borders of the Aryan state but is not a potential citizen. Guests shall be members of non-Aryan races, convicts or mentally handicapped individuals.

WILL THERE BE ELECTIONS IN THE ARYAN STATE?

In the beginning they will be maintained, but the candidates will not belong to factions with antagonistic interests but to the common interest, so that they will soon disappear because they have no reason to exist.

WHAT RELIGION WILL THE ARYAN STATE PROFESS?

The important thing about religion is that it should be in accordance with the laws of nature; it does not matter which religion is professed, so long as it collaborates with the biological ascent of the race and of man.

WILL THERE BE FREEDOM OF EXPRESSION IN THE NEW STATE?

Of course, in an order that responds to natural laws there is no need to suppress any opinion or expression, as we know that there can be no more perfect order. Therefore, whoever wants to

speak will be able to do so, the state will only act by the use of force in case of an attempt to subvert this order.

WILL CRITICISM OF GOVERNMENT POLICIES BE ALLOWED?

Of course, but criticism and questioning should be aimed at improving those policies and not at diverting them from their natural functions.

WILL THE NEW STATE BE AN AUTHORITARIAN DICTATORSHIP?

Not at all, the states that require the most control and restriction are those whose populations are the most degraded. As the race ascends and genetically improves, controls over the population will be less and will be concentrated more on the borders in order to prevent the intrusion of foreign blood into the state.

WHAT WILL EDUCATION BE LIKE IN THE NEW STATE?

It will focus on strengthening the character and capacities of the individual. It will not seek to mould subjects into equals, but to discover the differentiation of capacities so that they can be used for the common good.

WHAT POSITION WILL THE ARYAN STATE TAKE ON DRUGS?

As for so-called "recreational" drugs, those that affect brain cells, such as marijuana and cocaine, will be immediately banned and their marketing severely punished. Other "legal" drugs such as alcohol and tobacco will be gradually withdrawn in this order because the state must guarantee the physical and mental health of the race, and the white man's brain is his main resource for the struggle for life, the creation and progress of civilization.

As for medicinal drugs, they will be progressively replaced by natural products which will fulfil the same function.

WILL THE ARYAN EMPIRE HAVE A COLONIALIST POLICY?

No, it will only secure living space for the population and development of the white race. It will have no interest in ruling coloured men, as we are suffering today from our former "ruled" in our own territories.

WOULDN'T THE ARYAN EMPIRE HAVE A GLOBALIST POLICY TOWARDS THE NATIONS THAT WOULD FORM IT?

On the contrary, the cultural and linguistic diversity of the nations and their autonomy would be respected to the utmost, only that these nations would have to speak the common language of the empire in addition to their own language. Moreover, all the local customs and languages of the

European nations are the product of the contacts that different peoples of the same race have had with each other and are therefore subject to constant modification.

The function of the Aryan empire is the rise and progress of the white race and that can only be achieved by unity and not by keeping us divided into different national states, we will no longer compete with each other but work together for a single common good, each will contribute his best for the general welfare, therefore all kinds of war and economic confrontation between us will disappear.

WHAT IF ONE OF THE NATIONS THAT MAKE UP THE EMPIRE WANTS INDEPENDENCE?

None of the nations would desire independence because it would be detrimental to itself, since it would be at the mercy of dangers such as coloured invasions and other disadvantageous situations such as the absence of collaboration and help from the empire in the face of needs or crises. The Aryan state will not tolerate secessionism and independence, since these always conceal intentions detrimental to the race.

WHY DO YOU OPPOSE THE POLITICAL INDEPENDENCE OF EVERY ARYAN NATION?

Because through the independence of each nation the white world is fragmented and its invasion, genocide and extermination is facilitated. A clear example is the following, if you comment on the situation of the white race in South Africa today, any white person from another country will tell you "we are not in South Africa, we are in France, Spain, England, Germany, Argentina, etc." when years ago all the blacks of the world united in demonstrations against apartheid instigated and aided by the whites themselves, who also took an active part in the boycott of their South African brothers. Can you now observe the self-destruction of the white race?

HOW CAN THIS SELF-DESTRUCTION BE PREVENTED?

With correct racial policy and education.

RACIAL POLICY

WHAT IS RACE?

Race is everything, it is what we are, what we were, and what we can become. For a NS it is the main concept, much more important than the homeland or the state, it is the true motor of history, the only history that exists is the history of race.

If the race is corrupted it loses its destiny and is shipwrecked into uncertainty. Of all the races on the planet only the white race can create civilisation and it is the one that has achieved the

greatest evolution, the others have reached a certain evolutionary point and have stagnated and if they have progressed it has been because of the interference of the white man.

WHO ARE WHITE AND WHO ARE NOT?

White is anyone who belongs to the 3 or 5 branches of the Aryan race, who bears its physical and mental characteristics, and who, when united with a similar partner, procreates children similar to himself. Non-whites are all coloured men (black and yellow) and those who have been genetically modified by crossbreeding with non-white races such as Latin American mestizos, Semites, Hamitic and Gypsies.

WHAT ARE THE BRANCHES OF THE WHITE RACE?

There are three main branches of the white race:

Nordic: its members are characterized by blond hair, light eyes, a tall stature, being dolichocephalic and a disposition towards creativity and bravery.

Alpine: its members have dark hair and eyes, a short stature, are brachycephalic and are noted for their cheerfulness and great industriousness.

Mediterranean: its members possess dark hair and eyes, short stature, are dolichocephalic and are noted for their intelligence and skill in art.

Each white nation and each white man possesses different proportions of blood of the three Aryan branches in their veins, the Nordic blood being the driving force of development, progress and civilization.

HOW DO RACES ARISE?

Races arise through natural selection (mutation and adaptation to the environment), interbreeding and inbreeding. The three great races: whites, blacks and yellows, originated by natural selection, while the Semites, Hamites, Gypsies and Native Americans arose as a result of interbreeding. In both cases, inbreeding is indispensable for the formation of the racial group.

HOW DOES NATURAL SELECTION WORK?

When a group of individuals is exposed to a given environment, those who possess the qualities to survive reproduce and that characteristic that benefits them spreads in the population, while those who do not have this condition perish. Different environments effect different selections, which explains the differences between the different races on the planet. Selection never stops and constantly operates by selecting certain qualities and discarding others.

WHY HAS THE WHITE RACE PROGRESSED MORE THAN THE OTHERS?

Because it is the only one that possesses the capacity to create. This is because it was exposed to the harshest natural selection which cleansed it of its defective elements and perfected it racially. Whereas the coloured races², having developed in milder climates, did not develop any inventive qualities and became contaminated with their biological waste.

WHAT POSITION DOES THE WHITE MAN OCCUPY ON THE PLANET?

He is the most perfect work of nature, the pinnacle of evolution, no other creature has achieved the development of the white man, and as such he is entitled to all the territories he can conquer with his natural gifts.

WHAT IS NORDICISM?

The recognition of the Nordic white man as the vital force behind the development of all the great white civilizations.

IS NATIONAL SOCIALISM OR SOCIAL RACISM NORDICISM?

Yes, but not in a purely physical sense, for the essence of the Nordic is his creativity developed by natural selection in his hostile native climate, it was the creativity in his genes that gave rise to all the great civilizations and even today wherever there is a creator it does not matter whether it is in Sweden, France, Italy or Hungary, his Nordic genes are at work in him. Genes that we all have, since there is no European who does not have Nordic blood in his veins, therefore Nordicism does not necessarily see the Nordic in individuals of a certain physical appearance but in every genetically healthy European.

To conclude, it is from the North that the creativity that has positioned the white race as the undisputed masters of the Earth comes, and that is why we are Nordicists.

WHAT WILL THE NEW EUROPEAN BE LIKE?

The most perfect European was the Roman, who was a combination of the strength and creativity of the Nordic with the intelligence of the Mediterranean. This blood combination was also found in the British Isles and the Iberian Peninsula and both England and Spain created the greatest empires in the history of mankind after the fall of Rome. But we must not forget the Nordic-Alpine combination that gave rise to the Germans, as one of the most creative and industrious peoples. Therefore, the advancement of Europe requires the combined efforts of all white people, and in my opinion, the new European must possess the physical strength and creativity of the Nordic, the intelligence of the Mediterranean and the industriousness of the Alpine. It is obvious that in the new future order selection cannot be left to chance, and it will be a state policy to select the best

individuals from the population and to see to the proper crossbreeding for the progress and perfection of the race.

ARE THERE RACIAL DIFFERENCES BETWEEN THE POPULATIONS OF EUROPE?

The differences that can be seen in each European nation are due to the proportion of blood of each of the branches of the white race they possess, for example in the case of Italy, we find that the country is divided by a rich and industrialized north, mostly Alpine, and a not so economically rich and rural south, mostly Mediterranean, this has led to great rivalries between the two regions and even the rich north wanted to separate and form a nation state of its own. But the reality is that the wealth of the north is due to the great industriousness of the Alpine (the German Miracle was also due to Alpine industriousness and obviously also to Nordic initiative) but the latter could not have achieved it with its labour morale alone, it had to resort to Mediterranean intelligence and Nordic creativity, both qualities acquired in its genetic material by assimilation with the indigenous Mediterranean and the conquering Nordic. The regions from which the Norsemen departed would also be considered poor and backward in today's eyes, but they transported their creative genes to the Alpines and Mediterraneans, and from the fusion of the qualities of each of their branches the white race became the supreme race on Earth. Therefore, if the Alpines isolate themselves and avoid contact with the Mediterraneans, they will be hindered in their development, and the same will be true if the Nordics avoid contact with Alpines and Mediterraneans.

In conclusion, there are no racial differences between European nations, but rather particularities due to their genetic make-up.

WHAT IS THE RACIAL SITUATION OF THE SEMITES, HAMITES AND GYPSIES?

The Semites and Hamites belong to the Caucasian stock but have been modified by interbreeding with yellow and black blood. Although there is a genetic kinship with the Aryans, the genetic alteration is such that interbreeding with them cannot be permitted without the Aryan element undergoing a racial modification.

The Gypsies belong to the outcasts or untouchables of India, those who are the product of interbreeding between two castes, remember that the Hindu castes were made up of distinct racial groups. At one time it was believed that the Gypsies belonged to the Aryan race because they spoke a language of Aryan origin, but this hypothesis was soon discarded since the Gypsies are composed of a mixture of all the races of the Indian subcontinent and form a distinct racial group with its own particular psyche.

ARE ALL INDIVIDUALS WITHIN A RACE THE SAME?

No. Within a race there are 5 types of individuals: creators, doers, assimilators and brutes.

Creators: they are typical of the white race and are those individuals endowed with the capacity of invention.

Doers: predominate in the white and yellow races and among the Jews, they are those individuals who, although they do not possess the capacity for invention, have sufficient intelligence to improve on the inventions of the creators.

Assimilators: found in all races. They are individuals whose only intellectual capacity lies in absorbing and reproducing information; to this type belong the students called "bookworms" or "book rats"; they learn instructions correctly and do not possess the ability to criticise or doubt what is shown to them as truth. They are excellent at learning and applying acquired knowledge but fail to produce new knowledge.

Brutes: found in all races, they do not possess the intelligence necessary to understand or absorb the most basic knowledge.

The first two are indispensable in any community, the third are necessary, while the last are easily replaceable.

Within the white race, the Nordics stand out as creators, the Mediterraneans as doers and the Alpines as assimilators, this is by no means to say that all northern Europeans are creators, that all southern Europeans are doers or that all central and eastern Europeans are assimilators, the three divisions of the white race have been interbreeding for centuries and there has been a great exchange of genes between them so that the qualities of one and the other can be found throughout the white continent.

HOW DOES A RACE DEGRADE?

By the absence of natural selection or reverse selection and interbreeding.

WHAT IS REVERSE SELECTION?

Selection that acts against the upward evolution of the race by favouring its degeneration, to be discussed in more detail later.

CAN YOU GIVE ME AN EXAMPLE OF RACIAL DEGRADATION?

For example, in Argentina, the white race, which is a race biologically prepared for hostile climates, found a territory rich in natural resources, this generated that the biological waste, eluding the natural law, survived and reproduced, reaching the present day in which subhumans make up 50% of the population. This is the reason why Argentina, in spite of being 90% inhabited by the white race and possessing a vast natural wealth, has not managed to get out of the third world, and it is also the explanation for the failure of Peronism, the Argentine fascist movement which, nourished by a degenerated human material, veered towards leftism.

WHAT IS MISCEGENATION?

The crossing between individuals coming from different racial backgrounds or with a high degree of genetic distance.

DOES MISCEGENATION PROVOKE AN ALTERATION IN THE INDIVIDUAL?

Yes

WHY?

Because the three great races developed in different environments through different selections, those who have been fortunate enough to thrive in hostile natural environments have been purged of inferior elements and thus their blood is cleansed of harmful endowments and empowered for survival in such environments, while those whose natural habitat was kind to their defective individuals have a contaminated genetic load, their interbreeding would be a debasement and harm to the former and progress to the latter.

COULDN'T THE RACES COEXIST IN THE SAME TERRITORY WITHOUT MIXING?

No, because even if the state dictates strict rules against miscegenation, this would be produced through illicit unions and sexual relations, therefore interracial contact in the same territory must be avoided.

WHICH IS MORE DANGEROUS FOR THE RACE, REVERSE SELECTION OR MISCEGENATION?

Both are equally dangerous, for the degraded individual or subhuman is no longer of any use to the race, he cannot be converted into a useful individual, he is a social bacillus that must be discarded, and the mongrel no longer belongs to either of the two races that make him up, and therefore has no place in the racial community.

WHAT IS THE SIGN THAT A PEOPLE HAS BECOME RACIALLY DEGRADED?

A people has become racially degraded when its components cease to pursue the common good and begin to move in pursuit of individual ends contrary to the general welfare, in other words, when their instinct of self-preservation exceeds their social instinct.

HOW DO YOU KNOW IF TWO ETHNIC GROUPS ARE RACIALLY ASSIMILABLE?

By studying their blood composition, if the samples of both groups show a similar distribution of their blood types it is because they belong to a common race, on the contrary if the samples show a dissimilarity in the distribution of their blood types we are faced with two different races and therefore unassimilable. For example, the Aryans are characterised by large amounts of groups O and A and scarce amounts of B, while the Semites and Hamites have a considerably larger amount of B blood, which indicates that there are racial differences between them of such magnitude that

the unions between Caucasians, North Africans and Asians with Europeans would provoke psychic imbalances in the populations of the latter.

IS THE UNION BETWEEN AN ARYAN AND A SEMITE OR A HAMITE AS HARMFUL AS WITH A BLACK OR A YELLOW?

The greater the racial distance between the interbreeding groups, the greater the imbalance of the hybrid of the two. In the case of a cross between an Aryan and a Semite or a Hamite, since there is a kinship, however distant, the lowering of the Aryan parent in the half-breed will be less than if the cross had been made with a member of the other two great coloured races, but it would still be harmful and degrading to the Aryan community.

WHY DO THEY SAY THAT RACES DO NOT EXIST?

To prevent the emergence of racial consciousness in the white population and to encourage their interbreeding with the coloured men, but while asserting this they encourage the pride of the other races which they take advantage of to advance upon the white man. So the only race that does not exist is the white race, while the other races not only exist but must be guaranteed the right to preserve and expand.

Not only does race exist but it is a natural phenomenon, in fact we always instinctively seek the company of our fellows, if we were lost in the middle of sub-Saharan Africa and one day found among the black population a white man, be he Swedish, German, English or French, we would immediately approach him, this is because the racial instinct is operating in us that leads us to recognise those of our own group.

WHAT IS THE RACIAL INSTINCT?

It is the natural impulse that leads us to approach or seek the company of our fellows, it manifests itself unconsciously in all creatures of nature. It only breaks down under unnatural conditions of life and only manifests itself again in critical situations. A clear example of racial instinct occurred in American prisons when white prisoners had to group together to protect themselves from attacks by coloured gangs.

WHAT IS RACIAL CONSCIOUSNESS?

It is the knowledge of the race to which one belongs with its history and achievements. It can be strengthened or weakened through education.

WHAT WILL THE OFFICE OF RACIAL CLASSIFICATION AND HYGIENE BE AND WHAT WILL BE ITS FUNCTION?

The Office of Racial Classification and Hygiene will be a body of experts in racial matters, composed of a corps of anthropologists, geneticists, criminalists, and physicians, and will perform the following functions:

-Award the corresponding eugenic certificates to couples wishing to marry and procreate, prior to this they will be analysed themselves and their respective family trees which will appear in a personal book that each individual must carry.

-The newborn child will be examined to determine his or her racial health, and, if the child possesses the necessary racial characteristics, he or she will be given a certificate of citizenship. If the child has a congenital pathology which affects his life in the community, such as a mental disorder, he will be considered as a guest of the state. Individuals living in non-white Caucasian countries who wish to receive Aryan nationality will also be examined by specialists who will carry out the necessary physical and psychological tests to ascertain that they belong to the white race and can be assimilated without causing racial contamination.

-The Aryan nationality will be granted to a man who has completed his compulsory military and labour service and to a woman who has completed her compulsory education and social service upon marriage. Applicants from non-white Caucasian countries may be granted citizenship once their Aryan status has been determined and they have married and previously served a period of time as a subject performing the duties specified by the state. Individuals who are the product of a union between an Aryan and a non-Aryan Caucasian prior to the establishment of the Aryan state shall be examined and it shall be determined whether they are fit to receive Aryan citizenship or must emigrate to the land of their non-Aryan parent.

Individuals who are found to be unfit to procreate because they carry defective genetic material but do not possess any dominant pathology affecting their community life may be granted Aryan nationality when they undergo the appropriate sterilisation procedure.

-The granting of certificates of racial cleansing and honorary Aryan citizenship. The certificate of racial cleansing shall be granted to a Caucasian who proves and demonstrates his Aryan status. The honorary Aryan certificate shall be issued to non-Aryans (Caucasians and coloureds) who are required to live within the Aryan borders for a limited period of time under special conditions.

WHO IS A PUREBRED?

Any individual with the physical and mental characteristics of a race who, when united with a similar partner, procreates individuals of the same type.

HOW DO I KNOW IF I AM PUREBRED OR IF I HAVE ANCESTORS OF OTHER RACES?

Unfortunately you cannot know for sure, because you only know your closest ancestors, you can only guess, but David Lane has given an answer to this question when he said: *"If someone looks White, acts White, fights White, then until their actions prove otherwise, they are our Folk. On the*

*other hand, regardless of pedigree or appearance, those who oppose, criticize, hinder or fail to support our cause are no friends of ours."*³

HUMAN GENOME STUDIES CAN FIND OUT YOUR GENETIC MAKE-UP AND BY STUDYING MANY INDIVIDUALS THEY DISCOVER THAT DESPITE THE RACE THEY BELONG TO THEY POSSESS GENES FROM THE MOST VARIED RACIAL GROUPS ON THE PLANET, SO ARE WE NOT PURE?

If they comply with the rule I explained above, yes they are, study Mendel's laws and you will see that pure individuals emerge from mixed lineages.

WHAT CAN YOU SAY ABOUT THE AFRICAN EVE THEORY? IF WE ALL CAME OUT OF AFRICA WE ARE ALL BLACK INSIDE?

As the Count of Gobineau said: "*human races differ as much from their common progenitor, if indeed they have had one, as they differ from each other*"⁴ taking as valid the theory of the African Eve, and even if she had been "black" the mutations that have taken place between the three main human races have differentiated them so much that they do not currently possess any genetic closeness between them that would allow their interbreeding without causing physical and psychic imbalances in the hybrid.

WHAT WILL HAPPEN TO THE COLOURED RACES LIVING IN THE WHITE NATIONS IN THE ARYAN STATE?

They will be repatriated to their respective territories to live and develop according to their idiosyncrasies within their natural environment.

WILL THE COLOURED RACES RECEIVE HUMANITARIAN AID FROM THE ARYAN STATE?

No, because that would upset the natural balance of the population and cause a demographic increase in relation to their natural resources, so they would begin to be an invasion threat to the Aryan state.

DON'T YOU THINK IT IS CRUEL OF YOU TO DENY AID TO NEEDY PEOPLES AND ALLOW INNOCENT PEOPLE TO DIE?

I am not cruel, nature must perform its function, our natural nobility (a product of the hostile environment in which we have developed and without which we would not have survived) has cost us dearly and is what will lead to our destruction if we do not begin to redirect that gift. The clearest example of this is South Africa, during the time of apartheid, a word unmentionable today, whites vastly improved the health services and systems of blacks, as a result of which blacks

exploded demographically and eventually displaced them from power by taking over the country they created and turned it into a world power. Today South Africa has descended into the third world like all of sub-Saharan Africa, whites are murdered on their farms and recently the African National Congress has passed a law to expropriate land from whites without any compensation and except for a few shows of solidarity from countries like Australia, there is no mass campaign in any city in the world protesting against this, Ah but yes, during white rule there were all kinds of demonstrations against South Africa with extensive media coverage and all kinds of punitive measures were issued from the international arena. It was only when it ceded power to the blacks that it was left in peace.

With what I have said I want to show you that the goodness of the white man can be detrimental to him, because it was other whites, and not so whites, who carried out the campaigns against separate development and the blacks used this situation for their own purposes. Nobility and solidarity is in our Aryan nature, we must not discard it but redirect it towards our own white brothers and sisters and not interfere in the actions of mother nature.

CAN THERE THEN BE NO FRIENDSHIP BETWEEN THE HUMAN RACES?

The races are natural competitors. There can be friendship until there is a point of discord between them. Which sooner or later there will be.

THE RACIAL WAR

WHAT IS RACE WAR?

It is the natural confrontation between different human groups for the vital resources of the planet with the aim of the survival and expansion of their race. In such a contest only the fittest and most evolved triumph while the others perish. Throughout history, the white race has proven to be the supreme race by defeating the coloured peoples in any contest.

DO YOU THINK A RACE WAR IS COMING?

It is not coming, it has already broken out, only that the white man is blinded by it, all the white countries are being invaded by the coloured peoples with the complicity of the ruling biological waste in each of them. In the old days these invasions were carried out through military campaigns. Today they are carried out peacefully and in disguise, through uncontrolled immigration and the view of the invader as a poor refugee. The danger we face today is greater than the danger we faced centuries ago when we were invaded by Attila and his Huns. Today we are not led by a biological elite to organise the defence of our land, nor do we have a white people with the qualities of our ancestors. Europeans today are in a state of decomposition and brainwashing that leads them to open their arms to the rapists of their daughters and to concern

themselves only with their own personal material well-being. In other words, the white race has been biologically degraded since the time of the Mongoloid invasions and that degradation is what produces its passivity in the face of the present coloured invasions.

SO RACE WAR IS NATURAL?

Exactly, it is enough for two races to come into contact with each other for the fittest to displace the other by various means. For example, it was not only the white man's ingenuity and military skills that enabled him to conquer America, but he was also immunised or in better physical condition to cope with diseases that were deadly to the aborigines.

HOW DOES THE RACE WAR DEVELOP?

The race war is fought on two fronts, an external one against the coloured peoples and an internal one against the biological waste or sub-humans.

IS THE BIOLOGICAL ELITE LOST?

No, the elites emerge and renew themselves in catastrophes or crises like the one we are living, they are the individuals who manage to see the danger of a situation for their own group reacting and facing this reality, once the critical situation or threat is overcome they become the ruling class and that is where the natural social order originates.

HOW IS IT INTENDED TO CONQUER THE WHITE COUNTRIES?

As we have already said, through uncontrolled immigration. A territory is invaded until the immigrant group is in the majority and that is when it claims the rightful ownership of the invaded land under the democratic principle of the "majority".

BY WHAT MEANS DO COLOURED PEOPLES INVADE WHITE COUNTRIES?

White compassion, biological waste (the biological froth: leftists, progressives, race traitors, corrupt politicians and unscrupulous businessmen) and the mediocre or useful fools.

WHAT DO THE CURRENT WHITE LEADERS DO IN THE FACE OF THIS?

Except for the United States, Russia and some countries in Europe, the entire white world is currently ruled by race traitors (subhumans who sacrifice their people and race for the good gratification of the ruling order) such as the current Prime Minister of Canada Justin Trudeau and the Chancellor of Germany Angela Merkel. These individuals literally open the doors of their countries to coloured invaders allowing them to carry out all kinds of atrocities on their own citizens.

WHAT DO YOU THINK ABOUT THE CURRENT CONFLICT BETWEEN THE UNITED STATES AND SYRIA?

Behind the US attack on Syria are the intentions of Zionism to attack Al Assad in order to favour ISIS who with their terrorist actions drive thousands of Syrians to leave their country and seek asylum in Europe as "refugees". driving the coloured invasion into white countries.

Donald Trump came to power with the promise of fighting ISIS and allying with Russia in the fight against terrorism, Al Assad saw him as a natural ally in his war against the terrorist groups that control part of his country, which is why many of us feel disappointed with his recent actions, but we understand that they are the product of the pressure that has always been exerted on the US government by the Judeo-Zionist lobby.

Our stance on the conflict is not to get involved, as neither side's objective benefits the white man.

WHAT IS YOUR OPINION OF THE CURRENT WORLD POLITICAL SCENE?

It is a very profitable time for our cause, as the world's major powers, the USA and Russia, are led by leaders who are guided by the common good and therefore share many interests and objectives with us. Many of us had hoped that Trump and Putin would unite to fight the coloured invasion of the white world, unfortunately Zionism pulled their strings to play them off against each other. On the other hand the current coloured invasion of Europe is a complete disgrace that is increasing our danger of extinction but white people are starting to become aware of this situation and are reacting, that explains the great popularity of Marine Le Pen in France and Geert Wilders in Holland.

BUT TRUMP AND PUTIN HAVE CRITICISED OR CENSURED THE NATIONAL SOCIALISTS, AS HAS APARTHEID SOUTH AFRICA.

Anyone who wants to bring order to the planet will sooner or later come up against National Socialism.

IS IT ACCEPTABLE TO ALLY WITH A NON-WHITE COUNTRY?

If such an alliance is against another white country, it is not acceptable. If it is against a coloured country that endangers the white world, it can be considered, but only momentarily, without strengthening that ally, which tomorrow will be our rival.

WOULD NOT SUCH A RACE WAR BE AVOIDED IF, AS THEY SAY, WE WERE TO UNITE WITH ONE ANOTHER AND MERGE INTO ONE RACE?

Crossbreeding is not a valid alternative to avoid racial war, first of all it would not solve any problem, it would plunge humanity into chaos until new races emerge from it and secondly crossbreeding is completely detrimental to some and beneficial to others, because some are degraded racially while others improve their race. It is known that the mixed race with whites possesses higher I.Q.'s than pure coloured men, but they possess a lower I.Q. than pure whites.

Peoples endowed with valuable racial qualities such as the whites and yellows avoid miscegenation, others such as the blacks and Native Americans desire it for two reasons: the first is the natural desire of the inferior to approach the superior, seeking to raise their racial level by hybridization, and the second is the conquest of the soil of the race they wish to invade.

WOULD THE ARYAN STATE PREVENT RACIAL WARFARE?

At first, yes, because each race will be repatriated to its natural habitat and their immigration within the frontiers of the Aryan Empire will be avoided, but nothing assures that in the future there will not be a war for vital space, what is certain is that if that happens, we will be prepared to face such adversity.

AND HOW CAN SUCH A RACE WAR BE AVOIDED ONCE AND FOR ALL?

By no means, it can only be delayed as long as possible through the repatriation of the coloured peoples to their regions of origin, but the natural competition of the races for living space and natural resources will eventually trigger it off. While under the laws of nature a population is maintained according to its territory and available resources, the differences in the degree of development achieved by the different races generates the desire of the less evolved races to go after the achievements of the more developed ones, which inevitably leads to racial conflict.

SO IS VIOLENCE AND RACIAL HATRED A NATURAL PHENOMENON?

Desiring the preservation of one's own race is a natural phenomenon, curiously when whites desire this it is called "racial hatred" or "xenophobia" but when races of colour desire it it is a "fundamental human right". What leftism calls "race hatred" in whites is nothing more than their natural survival instinct to see their soil invaded and their race and culture endangered by coloured people.

SO THE COLOURED PEOPLE HAVE NO RIGHTS?

Obviously they do, to live on their land, with their culture and to achieve the degree of evolution that nature has given them.

BUT, EUROPE IS MUCH LESS RICH IN RESOURCES THAN THE CONTINENTS OF THE COLOURED PEOPLES, WHY DO THEY WANT TO INVADE EUROPE?

Because the people invading Europe and other white countries today do not have the intelligence to effectively exploit the natural resources of their territories, so they decide to go after the fruits of white creativity and intelligence.

HAVE THERE BEEN OTHER RACE WARS BEFORE?

Yes, so far the white man has been the victor due to his warrior qualities, inventor and physical strength, but nowadays there are other factors working against him and in favour of the coloured

peoples that endanger their survival, for example the low birth rate of the white peoples and the high fertility of the coloured peoples and the movements in favour of the coloured immigrants (invaders) in the white countries.

CAN YOU NAME ANY RACE WARS IN HISTORY?

Yes, the Battle of the Catalaunian Plains, this was a defensive war against the yellow race that intended to conquer Europe, the conquest of the American West and the South African Great Trek, the latter two were expansive wars in which the white race fought for its living space against the coloured peoples. Paradoxically, leftism condemns when the white race fights for its living space but encourages when coloured races do the same in white countries.

SO DO THE COLOURED RACES HAVE THE RIGHT TO INVADE WHITE TERRITORIES?

If the struggle is fought by the rules of nature, yes, because if so, the more evolved peoples would win, as has happened throughout history when the white man was the undisputed conqueror of the planet, but today the coloured peoples have advantages beyond their natural endowments, such as the help and complicity of traitorous whites.

WHAT IS THE SITUATION OF THE WHITE WORLD TODAY?

It suffers the consequences of that misfortune called the "French Revolution", which I will explain later. It is under the noxious influence of liberal leftism, which has degenerated the Aryans from inventors, warriors and adventurers into merchants, and has split up into many independent nations, leading to rivalry among the Aryans instead of forming a single nation and defending themselves effectively against the coloured world, leftism (which will be explained in more detail) with its "political correctness" says that being white is a shame because the coloured races have been invaded and exploited, that races "do not exist", while it promotes pride and appreciation of the non-white races favouring their invasion of the Aryan countries, which should not be condemned but accepted as "poor victims", which our adversaries take advantage of very well.

YOU DON'T THINK IT WAS WRONG FOR THE WHITES TO INVADE THE LANDS OF THE COLOURED MEN?

No, because it is part of their will to power, of their nature, they have done it by their own means and they have fought for everything they have conquered. The vanquished coloured races today are trying to do the same, but because they do not have the same capabilities as the Aryans, they make use of the present degradation of the white world, in other times it would not have been so easy for them to set foot on European territory.

The Ottoman Empire also invaded black, Semitic and white lands and reduced all these races to slavery, why don't Muslims apologise? Instead they are "victims" of "white imperialism" and should therefore be allowed to invade Europe.

AREN'T WHITES TO BLAME FOR THE PRESENT SITUATION OF COLOURED PEOPLE?

The only blame white men have is that they have helped their rivals to reproduce beyond their natural limits and to use the means provided by the Europeans to attack and invade them. The coloured men blame the whites for their evils, but they owe to them all the technical advances they possess and the help they have received, are receiving and wish to continue to receive.

COULD YOU REPEAT WHAT WEAPONS THE COLOURED MEN MAKE USE OF?

Their high birth rate in comparison with the low birth rate of whites and the leftism which facilitates their advancement and expansion.

WHO WILL WIN THE RACE WAR?

Under fair and natural conditions the white race is the undisputed winner, for the white world possesses the most modern weaponry developed by its innate creativity and intelligence, but by artificially weakening the white race and strengthening the coloured races by the action of leftism the balance is tipped in favour of the coloured men.

THE SUBHUMANS

WHO ARE THE SUBHUMANS?

The subhumans or biological waste are the degenerate individuals of a race who do not contribute to the progress of the community, but seek to destroy it or distort it from its natural functions in order to serve their own particular interests. Subhumans are conscious that under the laws of nature they would meet their extinction. They arise when a race develops in a habitat of easy access to life, or when human creations modify the conditions of life to facilitate their survival. All races possess a certain number of subhumans, the coloured races in much greater numbers than the white race, but despite being fewer in number, the white subhumans are the most dangerous because they are endowed in many cases with intelligence, which they use for their harmful purposes.

Every white country is contaminated by them; in some cases, as in Argentina, they make up half the population, so there is no way to rid the country of them with a democracy or a national revolution; a world movement is required to enable us to apply the corresponding measure to them without any other contemplation than the survival and advancement of the white race and the repopulation of the liberated territory with the help of other white brothers and sisters who wish to inhabit it.

The sub-humans act as a cancer within the racial body, and if they continue to spread throughout the white world, they can lead the entire Aryan race to a point of no return and the inevitable death of Western civilization.

HOW DO HUMANS DIFFER FROM SUBHUMANS?

Subhumans have a mutation in the MAO-A gene, which is responsible for controlling aggression through the breakdown of the neurotransmitters (chemicals that carry signals from one neuron to another) serotonin, norepinephrine and dopamine. As the MAO-A gene is inactivated by such a disorder, the neurotransmitters are not eliminated and accumulate in the brain, making carriers of this abnormality violent and vicious.

Humans have a natural sensitivity to the suffering of others; when they witness a scene in which a peer is afflicted by an illness, they feel uneasy because they remember the feeling they themselves have experienced in a similar situation, or instinctively they put themselves in the place of the unfortunate person and try to help alleviate it. The subhuman does not possess this natural sensitivity or any kind of feeling for any other individual but himself, so it is impossible for him to live in community. Proof of this are the prisons, where these individuals do not achieve any kind of coexistence and are in a permanent state of violence against each other.

DO SUBHUMANS WANT TO CONQUER THE WORLD?

No, subhumans only seek to satisfy their immediate interests or pleasures, they have no notion of posterity, no group consciousness, when they aspire to positions of power they only wish to ensure their enjoyment during their earthly life. If it is true that they can be used by other races or groups who do desire such a goal.

WHAT ARE THE DEMANDS OF SUBHUMANS IN SOCIETY?

Freedom, they constantly support leftist causes for the sole purpose of obtaining "freedom" to commit their misdeeds. The capitalist desires the "freedom" of the state, guild or trade union in order to exploit the worker to the maximum and the asocial criminal desires the "freedom" of the police to rob, murder or rape his victim.

WHAT IS THE SOLUTION TO THE PROBLEM OF SUBHUMANS?

Eugenics and racial hygiene.

EUGENICS AND RACIAL HYGIENE

WHAT IS EUGENICS AND RACIAL HYGIENE?

Eugenics is the science that seeks the progress of the race, which begins by ensuring the procreation of physically and mentally healthy individuals and then ensures that they possess the appropriate environment and elements to develop their physical and mental capacities and abilities to the maximum for the benefit of future generations.

Racial hygiene consists in stopping the degradation of the race by sterilising genetically diseased individuals or those with hereditary endowments that are likely to give birth to children with such abnormalities, and in the confinement of all those abnormal and incorrigible individuals who threaten the community.

SO YOU BELIEVE IN THE INHERITANCE OF ACQUIRED TRAITS IN MAN?

Of course I do and it has been demonstrated by the study of twins separated at birth and brought up in families of different social classes, these twins even in different environments and without even knowing of each other's existence were more alike than two ordinary siblings brought up under the same roof and in the same environment.

BUT I THOUGHT WE WERE ALL THE SAME AT BIRTH.

Ironically, those who maintain that we are all the same are fervent supporters of Darwin's theory of evolution, which is based on the inheritance of acquired traits. Man is another animal created by nature and as such is subject to its same rules.

WHAT ROLE DOES THE ENVIRONMENT PLAY IN SHAPING THE INDIVIDUAL?

The environment fulfils the function of impelling or retracting certain qualities that the individual carries in his germinal plasma, for example, under an environment that guarantees the individual an education, he will be able to choose the career and carry out the function for which he is genetically more apt, if he does not have an environment that gives him the opportunity to study, it is very possible that the individual will die without developing his aptitudes.

The environment provides the conditions for expansion according to the genetic constitution of the individual, but it cannot create abilities in the subject if he is not genetically endowed for them.

HOW DO WE KNOW IF WE DO NOT CARRY GENETIC ANOMALIES IN OUR DNA CAPABLE OF BEING PASSED ON TO OUR DESCENDANTS?

We all possess what is known in genetics as "black genes", these are genes that carry congenital pathologies but are not dominant, because we have surely had among our millions of ancestors some who suffered from some genetic condition, therefore we must make an analysis of our close family tree and based on the same unite with a partner who has a family tree as healthy as possible. In the new racial state this activity will be carried out by the Office of Racial Classification and Hygiene.

WHAT IS REVERSE OR UNNATURAL SELECTION?

Under the rules of nature only the fittest survive, i.e. the strongest and bravest, the same happens under a social system faithful to these laws. Under capitalism, the most selfish, cowardly, unscrupulous and corrupt survive, those who under natural power would perish, while the noblest and bravest are relegated to the lower classes due to their lack of rapacity, perishing for various reasons such as starvation and suicide. This also has repercussions on sexual selection, for it is no longer the best men who are sought after by the best ladies, but those who have the money to provide them with a life of comfort, and so they unite with the biological waste, both white-collar criminals (biological froth) and asocial criminals (biological dreg).

WHEN DOES REVERSE SELECTION TAKE PLACE?

When the environment that gave rise to the race is adulterated in pursuit of particularities contrary to those indispensable for survival in the natural environment.

HOW IS REVERSE SELECTION TO BE REMEDIED?

By replacing it with natural selection, but since we cannot go back to the time when nature was in direct control of man, the state must ensure that only those individuals are born into the world who are chosen by nature to survive, who win the first battle of birth. Nowadays, the death of those who are born defective is avoided by all possible means, but this leads to an enormous expenditure by the state on completely unproductive individuals who, moreover, depending on the pathologies they suffer from, can be harmful and endanger other healthy individuals who have to carry them on their backs for their entire lives. By surviving they also reproduce, causing genetic contamination of the breed.

The state as breeder of the breed must ensure the survival and advancement of the best elements and prevent the reproduction of the inferior or unfit. If reverse selection has caused serious racial pollution, then when the natural social order is re-established, the state must remove all defective individuals and initiate the regeneration of genetically and racially healthy individuals. A clear example of this being possible was provided by Benito Mussolini. The white Mediterranean race in southern Europe, having developed in a less hostile environment than the Nordic race, suffered a slight subhuman contamination which gave rise to Mafia organisations. The Duce, by mercilessly combating the Mafia, purged all the inferior racial elements and freed the Italian people from these social bacilli.

Then follows the environment in which these individuals are to develop, this must be the same as the natural environment where only the strongest, fighters and selfless survive and procreate by improving the race with their genetic endowments. But in a system where a war hero begs for alms in the street, where a worker lives in misery and where the importance of an individual is based on how much money he has, this is not possible, therefore a new sexual selection is required in order to start with the improvement and progress of the race.

HOW IS A NEW SEXUAL SELECTION GENERATED?

In the same way that young girls are currently taught with subliminal messages that they must choose their partners by their purchasing power in order to lead a life of luxury and comfort. In the new order they will be taught that the woman's duty will be to choose the partner who will give her the healthiest children, because we know that in natural sexual selection the female, when choosing her partner, chooses the one who, because of her conditions, can give her the most perfect children. In other words, a woman does not fall in love with a man but with the children he can give her. In the new order subsistence will cease to be a preoccupation, so that from an early age both sexes will be subjected to the corresponding physical training and to a new morality which does not see sex as a mere act of pleasure or a dirty and degenerate act, but as the means by which the race is improved. A man's prestige will lie in being physically healthy and fit to be chosen as a procreator, and a woman's prestige will lie in being physically healthy and fit to be the mother of the best white children.

GOING BACK TO BIRTHS, ISN'T WHAT YOU SAID ABOUT CHILDREN BEING BORN WITH ABNORMALITIES VERY RUTHLESS?

That's the way nature has arranged it, you see, through death she maintains the balance of the population. More boys are born than girls, but boys are immunologically weaker, and so throughout childhood they begin to die off until they reach the age of puberty and procreation and there is a boy for every girl. If men interfere, they upset the sexual balance perfectly controlled by nature.

WILL GENETIC ENGINEERING BE USED FOR THE IMPROVEMENT OF THE RACE?

Yes, we will use any means that will help the progressive advancement and perfection of the white race. In the case of genetic engineering, it could make it possible to modify or override harmful genes in healthy individuals, allowing them to reproduce and parent.

THE SUPERMEN

WHAT ARE SUPERMEN?

Supermen, also called indigo children, are those individuals who are not guided by established values but by their own natural instinct following their will to power. Because of this they are in constant conflict with the unnatural rules of the present order. They are the survivors of the first natural human societies where only those endowed with initiative, tenacity and courage survived.

WHAT ROLE DO THEY PLAY IN THE CONSTRUCTION OF THE NEW ORDER?

They are the ones who actively carry the qualities of the Aryan race and who will re-establish the natural social order, since they instinctively analyse all phenomena by means of their common sense.

WHY ARE THEY SO RARE?

Due to the genetic degradation that the white race has suffered throughout history and especially in the last 200 years, the birth of supermen has diminished to the point of near extinction, their arrival in the world is due to the survival of old genes.

ARE SUPERMEN THE OFFSPRING OF OTHER SUPERMEN?

No, they can be born of absolutely normal parents, since like genius musicians who require a conjunction of genes obtained from both parents at random, supermen are also likely to require the fortuitous combination of certain genes.

WHAT WILL THE NEW ORDER DO WITH THEM?

The new order will promote the genetic, physical and psychological improvement of the race with the aim of creating a white man superior to the present one, for this purpose the procreation and development of superior men will be promoted and if the future allows it, genetic engineering will be used, for this reason procreation will not be an individual matter but the state will be present in it.

ARE YOU A SUPERMAN?

I will answer with the same words of Commander Rockwell "*All I am is the offspring of millions of years of evolution that white Christian society has produced*".

NATURAL MEDICINE

WHAT WILL BE THE ROLE OF MEDICINE IN THE NEW ORDER?

To collaborate with the health of the population without interrupting the action of nature, it will only be a complement to the self-recovery function of the human body. All pathologies will be treated by the most natural and effective means possible. As pharmacology will no longer be a millionaire's business as it is nowadays in the capitalist era, diseases that are nowadays fatal and cause great suffering to the patients who suffer from them and their families, such as cancer, will cease to be so.

WHAT WILL NATURAL MEDICINE CONSIST OF?

Firstly, to improve the living conditions of the population, as there are currently an infinity of pathologies that are produced by the abnormal living conditions of urban societies, and then to help the body to correctly fulfil its self-repairing function. I will give you an example, you break a bone, at the moment you fractured it your brain sent the order to repair the damage, but if the bone has been badly positioned it cannot be repaired in its correct location, this is where the doctor intervenes, placing the bone correctly in its place so that the body can effectively carry out its function. Doctors and medicines will only be auxiliaries or helpers of the human body in its self-recovery.

CAPITALISM, COMMUNISM, AND BIOLOGICAL SOCIALISM

WHAT IS CAPITALISM?

Capitalism is economic leftism, it is the system where individuals in absolute freedom pursue their own selfish interests at the expense of the needs of the community. In capitalism the elites are not the strongest physically, mentally and intellectually, but those who have accumulated the most money in their pockets.

DOES CAPITALISM REPRESENT A DANGER TO THE WHITE RACE?

Obviously. In the first place because of the inverse selection it exercises on the population in favour of the unscrupulous and corrupt individual and against the noble and struggling one and in the second place because it exposes the race to miscegenation by allowing the entry of coloured immigrants to be used as cheap labour and when foreign races that manage to position themselves in the upper classes because of their monetary wealth, the only element of power and respect in this system, manage to take as wives the best ladies of our race.

WHAT IS COMMUNISM?

Communism is social leftism, it is the system that arises to "protect" the victims of economic leftism or capitalism. The way to save these victims is by handing over to the state all the goods and means of production so that the state can create an egalitarian and just society. In communism, the elites are not the best physically, mentally and intellectually, but the leaders of the state and their cronies.

DOES COMMUNISM REPRESENT A DANGER TO THE WHITE RACE?

The former soviet communism was strongly traditionalist after it experienced the dire consequences of progressivism in the early days of the Bolshevik revolution, that has been fortunate for the Russian people since it prevented its degradation, in fact if the liberal West had

taken the same measures as the USSR did in the face of the AIDS epidemic of the 80s: mandatory AIDS testing, isolation of the sick, deportation of the infected foreigners, the disease would not have spread and could have been eradicated, but despite being politically conservative, it financed and encouraged progressivism in Western societies to break them down and weaken them in order to expand its power over them.

Today's communism is progressive and encourages by all possible means the decomposition of white peoples, promoting a reverse selection in favour of the most mediocre and assimilationist elements to the detriment of the creators in order to keep the regime unchallenged.

Communism is based on false premises and therefore requires for its subsistence a mass of assimilators who blindly believe in what they are taught, so it must eradicate creators and doers from the population. The doers represent a danger to communism because even if the creators are eliminated, the doers can take their works and continue them.

The elimination of creators leads the community to lower its qualitative level, to stagnate and not to progress.

DO THESE POLITICAL SYSTEMS CREATE SUBHUMANS?

No. The subhumans create these systems and what these systems do is to benefit them and favour their multiplication. But depending on the degree of perversion of a people their effects will be greater or lesser, for example as I said before, the Russians saw that progressivism would destroy them and they eliminated it immediately. The post-war Germans under a capitalist system and an occupying government, by their own condition of tireless workers, produced the economic recovery never seen before in history, which came to be known as the "German Miracle". The success of Swedish social democracy is due to the fact that the Swedish people have not undergone significant changes in their racial quality. Whereas other, more degraded societies, such as Argentina, under such systems drastically accelerated their decomposition.

SO COULD WE LIVE UNDER THESE SYSTEMS?

No, because they are unnatural and sooner or later subhumans who manage to climb to positions of power begin to survive and reproduce due to the rules of social ascent of these systems that do not reflect those of the natural social order and the race begins to decompose.

BUT, SOME WHITE NATIONS SUBSIST UNDER CAPITALIST ECONOMIES WITHOUT SOCIAL BREAKDOWN.

The fact that they do not decompose socially means that these people possess sufficient racial health to resist the action of that harmful agent, just as an immunologically strong human body can resist disease much longer, and even be cured, than an immunosuppressed body. But while internal deterioration does not take place, or takes place more slowly, decomposition comes from outside through the immigration of colour needed by the system to make labour cheaper.

WHAT IS BIOLOGICAL SOCIALISM?

Biological socialism is the economic social system based on the laws of nature, in which each individual obtains the social position which corresponds to his natural endowments and possesses as much as his abilities and effort allow. Biological socialism is oriented towards the preservation and advancement of the race by means of natural selection and legislation based on it.

WHITE GENOCIDE

WHAT IS WHITE GENOCIDE?

The systematic extermination of white peoples by coloured races and sub-humans.

HOW IS IT CARRIED OUT?

Through the support of leftist politicians for the rivals of the white race (coloured races and sub-humans) in other words through racial betrayal.

WHAT ROLE DOES ZIONISM PLAY IN THE PRESENT SITUATION OF THE WHITE WORLD?

Zionism has been trying to break down the white world since 1789, and before that too, nation-states, political structures based on language and a flag but not on race, are a creation of its own to divide and confront white men. Today the Khazars (Jews) have their own state in which they prohibit miscegenation and restrict immigration to members of their race only, but to achieve their goal of world domination they must racially destroy the white man, who is their main competitor, and they have a man in charge of this task: George Soros.

Soros is behind every organization, institution or movement that degrades the European, yet now he has set out to destroy Israel as well as the Western European nations and Israel considers him an enemy. This fact only demonstrates the extremely developed survival instinct of this race, which prevents or hinders them from maintaining any nation state, for which loyalty is required. Soros does not want Israel to rule over the world, but he wants to rule over a degraded and mongrelized world and so he wants to bring his blood brothers into it. Strangely enough, therefore, Israel and the Aryan world have a common enemy: Soros and his agents.

Once this danger is destroyed, we can tolerate the Zionist state if the latter minds its own business and does not interfere with the white world.

I consider it important to mention three things that we must learn from our enemies: they do not divide themselves into nations or confront each other, they recognize themselves wherever they live as belonging to Israel, which is a racial homeland. They do not allow miscegenation, even though they are a mixed race between yellows, Semites and Europeans and to their white genes

they owe all their technological advances and the existence of the state of Israel. They restrict immigration to members of their race; applicants for Israeli citizenship must prove they belong to their lineage.

IS LEGAL ABORTION PART OF WHITE GENOCIDE?

Of course, abortion propaganda is always aimed at white women who are better endowed for reproduction. Recall that in the United States since abortion was legalized in 1973, most of those aborted were white children and in the Soviet Union most abortions were performed in the villages of White Russia.

NON-WHITE CAUCASIANS: JEWS AND ARABS

SO, ARE THE JEWS A RELIGION OR A RACE?

Excellent question, Judaism is a religion but the people referred to as Jews are a particular race who have adopted that religion, it would have made no difference what religion they chose to profess, what characterises the Khazarian people is their race not their religion. It is common to find individuals under the Jewish religion who have no kinship with Khazars or Semitic Jews. The same is true of Islam, the Albanians and Croats of Islamic faith are Aryans, but not the Bosniacs who live on European soil but are descendants of the Turkish invaders. The new Aryan order will open its doors and arms to all physically and psychically healthy Aryans on the planet regardless of their native religion or the place or culture under which they were born.

The diverse genetic combination that makes up the Khazarian race causes an instability common to all mongrel peoples; if the individual's Aryan blood predominates, this will manifest itself in his physical and psychic characteristics, and if his Semitic blood predominates, the same will be true. To fulfil the objectives of Zionism, world domination, both genetic endowments are required but at a stable level, which often does not occur, for example in George Soros his racial composition makes him a pathological egoist harmful even to his own people and in Bobby Fischer, in whom Aryan blood predominated, it turned him into a "renegade" of his people or a Jew who "hated himself".

In the Aryan nation, those Jews who prove to be racially Aryan can apply for the appropriate blood cleansing certificate that will make them aspiring citizens of the state.

WHAT ARE THE DIFFERENCES BETWEEN THE ARYAN AND THE JEW?

The Aryan is creative, adventurous, idealistic, and possesses a low instinct for self-preservation, while the Jew is commercial, materialistic and possesses a high instinct for self-preservation.

WHAT DO YOU THINK OF THE SIX MILLION JEWS MURDERED BY NATIONAL SOCIALISM?

The "holocaust" and the "six million" have been proven false by numerous researchers and intellectuals. But the system has elevated this story as a god to be worshipped by the entire West, since it is of vital importance to the ruling regime, for if proven false the people would change their appreciation of the Fuhrer and the NS would become a valid option to choose from and by solving the problems of the common man would be embraced by the majority of the population.

Sooner or later the falsehood of the "holocaust" will be revealed as was the Katyn massacre, which was believed until 1990 to have been carried out by the Germans, when in fact it was carried out by the NKVD (Soviet secret police) and the truth came out when the Soviet Union collapsed and the documents ordering the massacre were declassified.

The holocaust is also of vital importance to the state of Israel as it obtains subsidies from the German state paid for by the toil and sweat of its people.

THE ARABS

WHAT IS THE RACIAL MAKE-UP OF THE ARABS?

The Arabs comprise within their borders the Hamites, products of the mixture between black and white, and the Semites, made up of the mixture of white, black and yellow.

WHAT ARE THEIR RACIAL QUALITIES?

Like the Jews to whom they are closely related, they possess skills in commerce and use economic wealth to climb to positions of power in the white nations to which they migrate, but unlike the Jews, the Arabs possess skills in warfare.

DID THE ARABS CREATE THE CIVILISATIONS OF MESOPOTAMIA AND NORTH AFRICA?

No, those civilisations with their palaces and historical monuments were created by the white race, the present Arabs live on the ruins of an alien culture, being themselves a race distinct from the ancient race of those territories.

ARE ARABS ASSIMILABLE IN WHITE TERRITORIES?

Only those who have been able to preserve themselves white both physically and mentally, which are very rare, can be granted a certificate of racial cleansing, such a measure having to be approved by the Office of Racial Classification and Hygiene.

A PROOF OF THE RESULT OF MISCEGENATION:

THE GYPSIES

WHAT IS THE RACIAL MAKE-UP OF THE GYPSIES?

The Gypsies belonged to the so-called Indian outcasts, the "caste-less", who were the product of miscegenation between members of different castes. The Gypsies are made up of various proportions of white, Negroid (Australoid) and yellow blood and an inbreeding that made them a race distinct from the Hamites and Semites.

WHAT RACIAL QUALITIES DO GYPSIES POSSESS?

Gypsies are noted for their illicit business, dishonest trade, swindling and blood crimes, and they share with the Negroids the magical and superstitious cults. Physically, they are distinguished mainly by facial features reminiscent of the witches in the fairy tales of the Brothers Grimm, which produces a visual impact or sense of dread in the viewer.

ARE GYPSIES ASSIMILABLE IN WHITE TERRITORIES?

No, because through the initial interbreeding and hundreds of years of inbreeding, they are today a race that is completely unassimilable to whites. If they cannot be repatriated to any ancestral territory, they will have to be kept temporarily within the borders of the white state, but separated in a space set aside for them without the slightest contact with the Aryan inhabitants. In the future they should be sent to a territory outside the Aryan borders where they can live and develop.

LEFTISM

WHAT IS LEFTISM?

Leftism or progressivism is the ideology used by biological waste to intervene in the natural order and break its rules by creating new ones that favour its survival and expansion.

WHAT DOES LEFTISM CONSIST OF?

As we have already explained, leftism or progressivism consists in the acceptance of everything that breaks with natural law. It is a cancer that arose with a little tumour called "The Social Contract" and its opening sentence "*men are born free and equal and society perverts them*" so we are all equal, nobles, bourgeois and peasants, men and women, white, black and yellow, we can all be what we want, blacks can be white, men women, women men, races and sexes are not products of nature but "social constructions" that can be altered at our whim. As human beings are also "social constructs", an individual is not a human being until he or she leaves the womb

and "becomes human", so in the meantime he or she can be murdered, since it is not murder because he or she is not yet human.

Moreover, since man is "good by nature" and society is to blame for his evils by corrupting him, he cannot be convicted of any crime since it is not his fault but society's that led him to do those actions.

This little cancer has metastasised and spread throughout the world. The Fuhrer tried to extirpate leftism from the planet but although he found the right medicine, he erred in its application, leftism cannot be eliminated in a single corner of the world because this would only be a temporary victory until it falls again due to the action of the pathogenic forces that control the main centres of power, the only possible victory is the worldwide elimination of leftism and the return to the natural social order.

WHAT ARE THE MAIN FALLACIES OF LEFTISM?

The main fallacies of leftism are:

"All men are equal": no one is equal to anyone anywhere in the world.

"Race is a social construct, there are no differences between human races": Race is a natural reality and by simply observing every continent on earth, racial differences can be seen.

"Man has stopped evolving thousands of years ago": Man continues to evolve and involute.

WHAT WAS THE FRENCH REVOLUTION?

A subversion carried out by the biological waste of the white race to create a world that would allow their survival and put the superior men (the nobles) to extinction. This subversion was carried out with the support of the assimilationist and mediocre masses taking advantage of their resentment towards the elites.

WHAT IS THE EFFECT OF LEFTISM ON THE WHITE WORLD?

It weakens them physically, psychically and spiritually, leaving them at the mercy of the subhumans and the coloured invaders who, unlike the white man, are strengthened by leftism.

WHAT IS THE DIFFERENCE BETWEEN LEFT AND RIGHT?

None, since the liberal right is also a left, in fact it was the first left, the subhumans of 1789 used liberalism to position themselves in power, today converted into a ruling social class their progressive children do the same, no longer to achieve power since they already have it, but to decompose what little is left of the old natural order, they propose to destroy families, sexes, etc.

WHY DO THEY DO THIS?

The nature of the subhuman is instinctively harmful, it knows that it has no place in the natural order and therefore all its efforts are directed towards its destruction. The main enemy of leftism is the most evolved and fittest in nature: white heterosexual males.

ARE ALL LEFTISTS SUBHUMAN?

No, many are ordinary people who are not intellectually strong enough to adopt a different way of thinking than the one imposed on them.

WHY DOES LEFTISM HAVE SO MUCH SUPPORT?

Because most of the population is intellectually mediocre and they see leftism, which posits that all mediocre and inferior people are equal to the elites, as a means of social climbing.

WHAT IS ANTI-RACISM?

Anti-racism is the means used by leftism to weaken and retract the white race while favouring the advancement and expansion of the coloured races, which for obvious reasons whenever they live in white majority countries vote for and actively support leftist parties and politicians. Anti-racism is an anti-white hatred supported by whites themselves, who due to the brainwashing of leftist propaganda believe that they are indebted to the coloured races for the place that the white race has achieved in the world and in history, therefore to repay that debt they must help the coloured men to take from the Europeans what they have worked so hard and suffered so much to achieve even their own lives which will be taken from them when the coloured men conquer their land.

WHAT IS THE END OF ANTI-RACISM?

To turn the white peoples into a mass of passive mongrels so that they can be ruled and controlled without difficulty, in other words, the ethnic cleansing of the white peoples.

WHAT IS POLITICAL CORRECTNESS?

It is the means used by leftism, disguised as "democracy", to censor ideas that endanger its existence.

BUT IN A DEMOCRACY THERE IS NO FREEDOM OF EXPRESSION?

No, there is a limited freedom, democracy provides a space through which one can move ideologically, but when one crosses the limits set, one enters into political incorrectness and receives the coercion of the system that tries to return it to the permitted ideological space.

ARE YOU A SUPPORTER OF FREEDOM OF EXPRESSION?

Obviously, today our struggle is mainly focused on obtaining the right to express ourselves freely. Once this battle is won and the working class is fed up with the consequences of progressivism, there will be nothing and nobody that can stop us on our way to power.

THE NATIONAL SOCIALIST REVOLUTION

HOW AND WHEN DO YOU THINK THE NATIONAL SOCIALIST REVOLUTION WILL TAKE PLACE?

The National Socialist revolution has already begun, in many parts of Europe the parties that look after the common good of the people, known as the "extreme right", are at the gates of power and in the United States the American people's weariness with liberalism and progressivism has brought to the presidency a new president. In the United States, the American people's weariness with liberalism and progressivism has brought to the presidency Donald Trump who has a discourse and ideas very close to ours and we could say that Trump's victory was, in a way, our victory, but not the final triumph, but a big step towards it.

To return to the question, the National Socialist revolution will culminate when it reaches the centre of world power: the United States of America, just like Christianity, which achieved world triumph when it became the religion of the centre of power of its time, Rome.

WHY DO YOU THINK THAT NATIONAL SOCIALISM OR SOCIAL RACISM CAN IMPROVE HUMANITY?

Evidence is everywhere, just study what life was like in National Socialist Germany and pre-1990 South Africa, but I will give you another example that no one will be able to tell you is false.

In 1960 Ron Jones, a history teacher at Cubberly High School in Palo Alto California decided to apply the National Socialist principles of conduct in his class and he managed to turn his class from a group of undisciplined and divided students into a community united around a common ideal, where they not only improved their school performance but began to collaborate with each other eliminating all kinds of discord among them, there were no winners or losers, no bullying, they were now a single force nurtured by the qualities of its components. You can see this in the film that was made about the experiment called "The Third Wave", and of course liberalism has been very critical of Jones' experiment because it infringed on "individual freedom", so imagine what humanity could be like under National Socialism.

ARE NATIONAL SOCIALISTS OR SOCIAL RACISTS REBELS?

Yes, but you must understand what the words revolution and rebellion mean. Revolution means to turn back, i.e. to return to a lost or interrupted state or course, and rebellion is not really to

oppose everything for the sake of it, but to observe a disorder and to wish to put things back in their proper place. We NS are rebels because we wish to return to the natural social order altered in 1789, if someone attacks the natural order he is not a rebel but a subversive. Subversion is the intention to replace one order with another regardless of the nature of the order one wishes to impose.

WHAT IS THE CURRENT ROLE OF NS?

The NS are the antibodies that the social body possesses against the human bacilli that try to destroy it, the more they are the more difficult it will be for the agents of decadence to carry out their harmful action.

IF I WANT TO BE AN NS, WHAT SHOULD I DO?

You must learn to be guided by your common sense and not by dogmatism, that is, you must be able to see for yourself the problems and their solution and not accept to be told what the problems are and what the solutions are. Then you must educate yourself through the doctrine but the essential of the NS is not that you believe blindly in something as Marxism wishes, but that what you believe you can corroborate it by observing the reality around you, a NS is not a "believer" in something that may or may not be, he is a fanatic convinced of the veracity of his ideas, because these ideas are corroborated in his day to day life.

WHAT POLICIES SHOULD AN NS SUPPORT WITHIN THE PREVAILING ORDER?

A militant NS should support all policies and political candidates that are oriented towards the natural social order, such as today's Trump, Putin, Le Pen and the European extreme right-wing parties.

WHY ARE THERE EX NS PEOPLE WHO REPENT OF HAVING SIMPATHISED OR MILITATED IN THEIR PARTIES AND HAVE SWITCHED TO THE OPPOSITE SIDE?

These people have never been NS, they have come to our worldview for a particular reason and the place they occupy today is the place where they always belonged. The NS is based on the laws of nature, there is no error in them, whoever having known the truth decides to return to obscurantism and superstition is because he knows that he would have no place in the natural social order.

WHY ARE THOSE WHO ARE ORIENTED TOWARDS THE NATURAL SOCIAL ORDER CALLED "EXTREME RIGHT-WING" PARTIES?

Because we are confronted with both liberal leftism and Marxist leftism, we are the right wing that in 1789 opposed the reforms of liberal leftism and wanted the continuation of the old regime. Today we call liberal leftism, which maintained some features of the natural social order, the right,

and Marxist leftism, which wishes to eliminate those few maintained features and lead the white race to total ruin and early disappearance, the left.

WHAT IS, IN YOUR OPINION, THE BEST WAY TO BE IN THE NS ACTIVISM?

The best way to be in the activism is as a lone wolf, having contact with other lone wolves and doing common activities but not doing formal parties or organizations where these are forbidden by law, which would make it easier for the enemy to discover us. As lone wolves we have more freedom of movement and can collaborate with any organization or support policies that benefit us or are in line with our goals.

THE ROAD TO A NEW WORLD

BAN COLOURED IMMIGRATION AND DEPORT THESE POPULATIONS TO THEIR PLACES OF ORIGIN.

The white race must be kept free from contact with unassimilable races, and for this reason white territories must not be inhabited by coloured individuals. Immigration or the invasion of colour is only possible because of the brainwashing to which the white man was subjected from the educational centres through leftist theories, fortunately, at present there is a reaction of the European countries against immigration which is expressed in their decision to leave the European Union. But Argentina, a country that has the richest reserve of natural resources on the planet and which are vital for the survival of the white man, is in danger of being absorbed by its coloured neighbours, it is essential that it follows the example of the United Kingdom and carries out a Brexit from Latin America, a continent with which it has no other common bond than speaking the same language, no cultural or racial aspect unites Argentina with the other countries of the region.

TO PREVENT THE PROCREATION OF SUBHUMANS.

The sterilisation of harmful individuals or social parasites is the second step, for our race cannot be promoted by the interference of biological waste in the life of the community. Those who are direct or indirect born criminals will be removed from the community, the birth of congenital morons or any individual useless to the community will be avoided, for these are maintained by the healthy and productive individuals, and only abortion will be used for this purpose. Those who are physically healthy but possess harmful genes which may give rise to moronic offspring should be sterilised.

Prisons will cease to be repositories of human rubbish and will be true correctional centres where only healthy individuals who have committed wrongdoings and must be reintegrated will be allowed, we believe that as the race progresses qualitatively, these institutions will be needed less and less.

STOP THE REVERSE SELECTION OF OUR RACE. STOP INVOLUTION

Liberal leftism has since it has been in power exercised a selection contrary to that made by nature, while nature selects for survival the strongest, most industrious and noble individual, economic liberalism has selected the most roguish and opportunistic. The warriors, adventurers and dreamers no longer have a place in the market world, they are useless, marginalised and finally in the process of extinction. As a result the white world becomes a herd of obese, selfish and ignorant junk consumers, ready to follow whoever dominates and guides them to their own interests.

Abortion, welfare, and misunderstood "compassion" allow inferior individuals to survive and reproduce, collaborating in the physical elimination of the best elements of the race.

We must reverse this process and thus prioritise the survival and reproduction of individuals more in line with our essence.

TO ENSURE THE BIOLOGICAL PROGRESS OF THE RACE. TO RE-ESTABLISH EVOLUTION.

With the state as breeder, it will ensure that the most physically and mentally healthy individuals will procreate, so that the race will improve genetically in each generation, producing a civilization that will reach levels of progress unimaginable to the white man of today.

THE UNION OF THE WHITE WORLD.

The white race cannot rise if it is divided, for it needs its peers no matter where they are. Every white community on the planet is united by the Aryan-Nordic genes that were received by all Europeans. This is demonstrated by the fact that all of Europe has given humanity superior men such as Beethoven, Edison, Tesla, Verdi, Newton, Carrel, Bernard, Favaloro, among others. If these men were born under different states and nations, can you imagine what they could all do united under one flag? This is our long term goal, for now we must support every nationalist movement that seeks to achieve power in every European country, once every country is under a truly European national government, it will be time to unite the white world and become the masters of the planet again.

THE 10 WHITE COMMANDMENTS

-KNOW AND LOVE YOUR RACE: study your genetic make-up and racial history, read about the civilizations and inventions your race has created and take pride in the achievement of every white man no matter what nation or ethnicity he belongs to. **REMEMBER WELL: IF HE IS WHITE, HE IS YOUR COUNTRYMAN.**

-WHITE RACE IS ABOVE ALL: Before you do any action in your life, ask yourself whether or not it helps the advancement of the white race. When you progress in your life and achieve your goals, you contribute to the advancement of the white race, when you decide to mate with a healthy person of your own race and have healthy children, you contribute to the advancement of the white race, when you make an invention or a discovery regardless of whether you are denied or not accepted by your contemporary compatriots, you contribute to the advancement of the white race. Your individual actions can never be separated from the common good; when you do so, you harm the white race and contribute to its retrogression.

-DON'T INJURE ANOTHER WHITE MAN: we are an endangered species, we are under a conceived plan of extermination by our racial enemies, but that is not the worst of it, **WE COLLABORATE DIRECTLY OR INDIRECTLY WITH THEM**, when do we do it? When we in any way harm or attempt against the life of another white man, when we participate in a war against another white nation, when we swindle or exploit another white man, when we despise or reject another white man etc. Remember this, **FOR A WHITE MAN THERE IS NOTHING BETTER THAN ANOTHER WHITE MAN**, think of other whites for what they really are, **MEMBERS OF YOUR RACIAL FAMILY** and therefore you are strictly forbidden to cause them the slightest harm, violence against another white man is only justified when it is in self-defence and when you have previously done everything possible to prevent it.

-HELP YOURSELF, HELP ANOTHER RACIAL BROTHER IF HE NEEDS IT: The welfare and happiness of one white man is the happiness and welfare of all white men, because it means the continuance of our stock into the future.

-DO NOT TAKE PART IN CAUSES THAT LEAD TO THE RETRACTION OF THE WHITE RACE: Before taking sides in a cause ask yourself first whether or not it benefits the white race, if it doesn't, then abstain. For example, if your political nation goes to war with another white political nation, your position should be to reject and oppose such a conflict, even though you may be considered a traitor, remember, your only loyalty is to your race.

-MAKE YOUR LIFE A STEP FORWARD IN THE EVOLUTION AND ADVANCEMENT OF THE WHITE MAN: strive to the utmost in your life to be the best at what you excel at, so that when you leave this world you will be a source of pride for your race and an example for future generations to follow.

-MAKE YOURSELF THE MOST PERFECT EXAMPLE OF THE WHITE RACE: develop yourself physically and intellectually, do sport and educate yourself, learn to defend yourself, try to progress personally every day, whoever sees you is seeing your race, let the gifts of the white race be expressed through you, you must be an empire made person.

-REJECT ANY VICE THAT HARMS YOURSELF OR OTHER WHITE BROTHERS: avoid drugs and substance abuse that affect your health and that of your racial brethren, also practices and rituals that degrade the spirit of the race.

-RECOGNISE YOUR RIVALS AND ENEMIES AND DO NOT COLLABORATE IN ANY CAUSE THAT BENEFITS THEM: if you take part in or collaborate with movements or organizations whose purpose is the advancement and progress of the coloured races or the subhumans, such as donations of medicine and food to Africa, buying products from non-white countries (although our economic condition does not always permit us to purchase products manufactured by whites because of the economic conditions of white nations and the unfair competition of coloured labour) or policies that deprive you of your natural right to defend yourself such as gun control, you are committing racial treason and collaborating with your enemies. Because the benefits they gain, such as numerical multiplication or learning how to use technology, will be used to your detriment in the future. For example: the yellows thanks to the technology learned from the whites became their main rivals in the dispute of the planet.

-RESPECT NATURE, CARE FOR AND PROTECT THE ENVIRONMENT: Nature is our mother, it has given us life and made us what we are today: the master race and owner of the earth. We must honour nature by preserving the environment for the proper development of future generations.

THE NATURAL SOCIAL ORDER

Suppose a catastrophe occurred and destroyed all civilisation and technology on the planet, leaving all human beings of all races living in a jungle or a desert in a primitive state.

Humans, as the social beings that we are, the first thing we would do would be to group together by a common affinity. And the main and most visible characteristic is the colour of the skin, so different human groups would begin to form according to this particularity, forming a white tribe, a black tribe, a yellow tribe, and so on. Then each of these tribes will look for a territory in which to settle, and so nations will emerge based on the sole title of racial belonging.

Each of these nations will possess different physical and psychological characteristics that will manifest themselves in the military field, among others, and this unequal ability to fight will cause the fittest to possess more territory than the others.

There is also no technological advancement, so the weak and ill-born will not be able to survive. Survival in this world will depend on struggle and sacrifice, so that the lazy, and the parasites will not be able to survive either, so life will be governed by the rules of natural selection.

The urgency to survive will make it impossible to hold "democratic" elections to choose leaders or occupants of any office. The strongest and most intelligent will take the lead on their own initiative and each person will contribute to the community according to his or her innate abilities.

The conditions of survival in each nation and the genetic capital inherited prior to the catastrophe is what will mould each of these races through the corresponding selection. Those who live in an eternal struggle for their lives will not be the same as those who have only to stretch out their hand and take the fruits of the trees. The former will be obliged to use their wits to get through the daily hostilities, while for the latter thinking will be of no use at all.

Well, each of these racial nations starts from the same point of primitivism, none of them possesses any resources other than their own genetic condition, remember, each of these nations is made up of people of a particular race, therefore no

people of any other nation can be accepted within their borders, so there can be no foreign genetic influence on them.

Little by little, each nation will evolve according to its genetic qualities and build up a specific culture, which will make each nation very different from the other, just as the different continents of the earth are different. The whites will gradually recover their inventions and technological advances, they will create the wheel, then the cart, then the automobile, then the aeroplane, and so on. The inventions and the goodness of the white man can lead to some unfit individuals outliving the natural law, and it is here that the Aryan himself must enforce it for the good of his posterity. If white society is preserved healthy without the cancerous influence of any "Rousseau", its evolution will not be interrupted and it will achieve ever greater biological and social perfection, which will make it the undisputed leader of the planet. On the contrary, the emergence of a social tumour such as that of 1789 would provoke an involution and the race would undergo a process of degeneration such as that which continues today and the consequences of which we are suffering.

The position achieved by the white nation will generate the suspicion of its coloured neighbours who will aspire to invade the white world to seize its civilization, which they could conquer, but if they were to do so, they would not be able to preserve it and would soon shatter it, as has happened in South Africa when the coloured men came to power.

Thus it is that race war will arise, coloured invasions will be inevitable and the white world will have to push them back; it may also happen that the white nation will need the resources of the coloured territories and thus need to expand into them. Here victory will go to the most technologically and militarily evolved, in other words, TO THE MOST FIT. And that is the natural social order, the victory of the best, and whether the coloured men like it or not, in nature the triumph belongs to the white man.
