111 - ROMANS

The Romans are one of the families of peoples of the Aryan race, along with the Germanic, Slavic and East Indo-European peoples (see Aryans). They settled in Europe, especially in the south and west of the continent. From the racial point of view they belong to the western human type of Aryanism. Historically, they are the creators and shapers of fascism, which, however, has proven inadequate to the current survival crisis of the white race in comparison to National Socialism. Therefore, National Socialism is now gaining adherents among the Romance peoples as well, fighting for the unification of all the Romance peoples of Europe into a Romance Federation as part of the Fourth Reich.

Although the historical National Socialism originally addressed itself exclusively to the Nordic-Germanic type of man, the plight of the Aryan race - as mentioned above - forces it now to conceive of itself as the organized will to life of the White Race as a whole. Bearers of this will are also in the Romance peoples the respective National Socialist parties, which are part of the National Socialist world movement (see also National Socialist German Workers' Party). Thus, the National Socialism of the new generation today also secures species preservation and species development of the Western human type, in its comprehensive struggle for the survival and the species- and nature-appropriate higher development of the entire Aryan race.

112 - RUSSIA

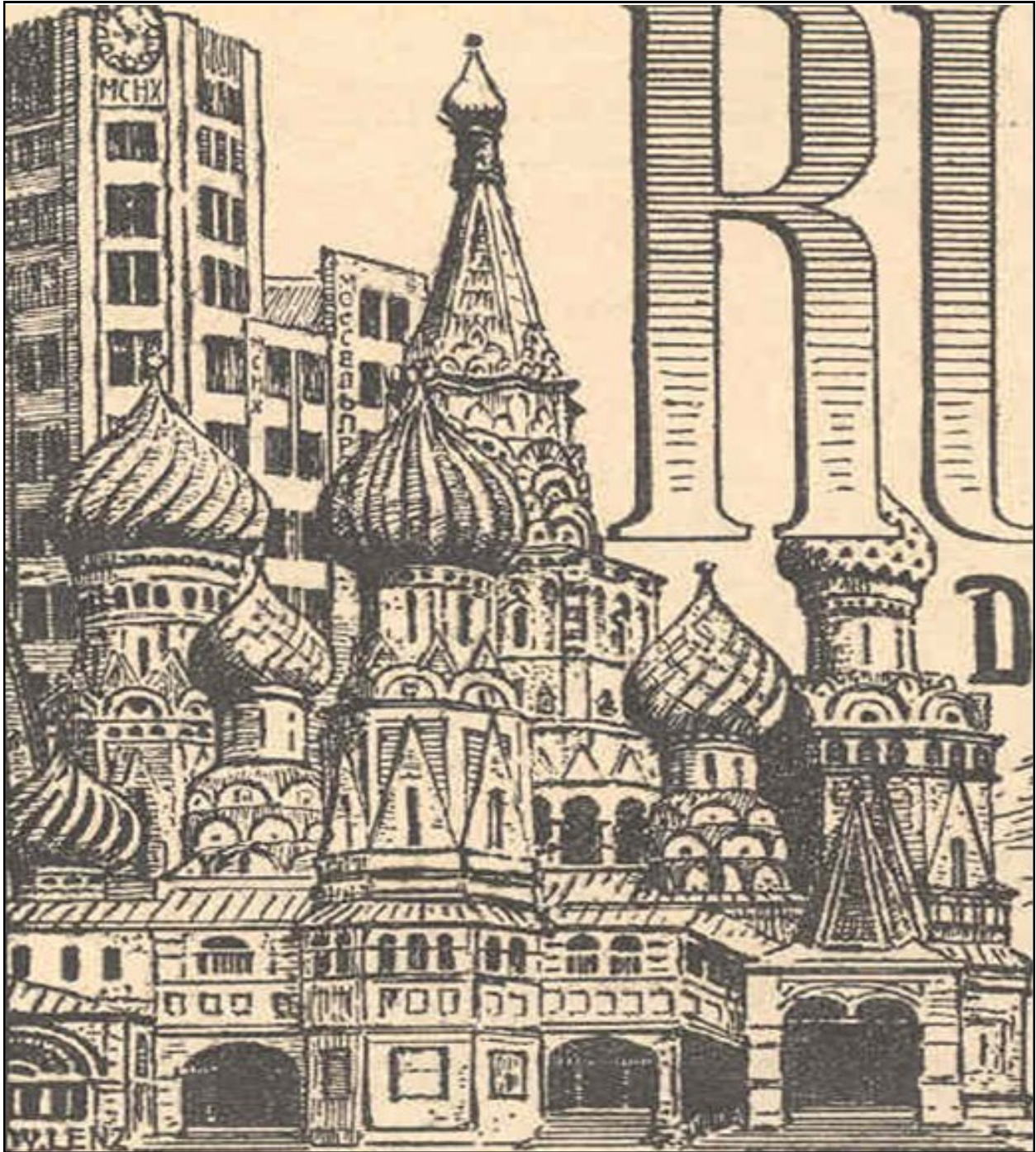
The Russians are the core people of the family of nations of the Slavs, racially seen therefore predominantly Aryans of the eastern race type. Historically, the Russians are heirs of the Eastern Roman Empire of Byzantium and thus ethnic car-



riers of the Eastern European imperial idea. Their political expression is above all Pan-Slavism, with its striving for the unity of the Slavic peoples.

From the tradition of Pan-Slavism will emerge a Russian and Pan-Slavic National Socialism, which will create a Slavic Federation within the coming European Greater Order of the Fourth Reich, in which the Russians, because of their historical impact and folk power, will be of important significance. From this perspective of national freedom and natural development of Slavs in general and of the Russian people in particular, National Socialism will gain the strength, above all in the Soviet Union, to spiritually overcome the ruling Marxism, to smash the communist dictatorship and thus to break its imperialism. A liberation of the Russians is the condition for the death of the Soviet empire!

The historical experience, especially of the Second World War, and the conditions of the nuclear age, however, forbid any belief in the possibility of such a liberation



from outside, or even through war. Only the Russians themselves are capable of this. With the proven foundation and continued existence of a Russian Nazi movement, as well as of other related national Russian and Pan-Slavic aspirations, this Russian liberation has already begun.

In contrast, the German National Socialism of the new generation abandons the idea of Eastern expansion and goes new ways of striving for sufficient living

space. The community of the New Front therefore strives, as a consequence first of all, for a national German Ostpolitik, with the goal of neutrality, in order to finally regain the unity, freedom and sovereignty of Germany.

113 - RIGHT OF SELF-DETERMINATION

Biological humanism as a natural-scientific epistemology of National Socialism strives for the knowledge of the biological nature of man, the influence of the laws of nature on his individual and community life, the consequences for the natural and cultural communities of man, and thus creates the conditions for acting in accordance with the species and nature. The most important biological foundations of social coexistence of people are:

Heredity, selection in the struggle for existence (see also elite) and differentiation, both in physical and in mental predispositions.

National Socialism takes into account the life laws of heredity and selection through a policy of racial hygiene and elite formation. From differentiation, National Socialism derives respect for the diversity of life, even in the biological species of man, which unfolds in individuals, sexes (see maternity), peoples and races. This becomes the basis of a policy of National Socialism which leads the individual to the personality, the people to the nation and the race to the Reich and the racially determined community of peoples, and which has racial segregation as its prerequisite.

National Socialism thus derives the right of self-determination from the biological natural law of differentiation and therefore demands for every race, people and ethnic group the right to survival, higher development and freedom.

Only those peoples will succeed in realizing this right of self-determination whose fellow citizens mature into a community of will, into a nation. Such a nation needs a will-bearer. Within the Aryan peoples (see Aryans) this task is fulfilled by the National Socialist world movement with its various parties. In Germany this is the National Socialist German Workers' Party. Therefore the NSDAP demands, already in point 1 of its party program, the unification of all Germans, on the basis of the right of self-determination of the peoples, to a Greater Germany.

A nation realizes its right of self-determination not only with the goal of the nation-state (see state), but it can also unite with other peoples to form an empire. The community of the New Front, as the core of the future, newly to be founded NSDAP, therefore fights on the basis of the right of self-determination, for the realization of freedom and self-determination of the German nation, within the framework of a large-scale order of the Fourth Reich, which is to encompass the entire large European living space (see also Europe).

114 - SENATE

The National Socialist Senate embodies the collective wisdom of the party and stands opposite the party leader, who, in accordance with the Führer principle, shapes reality with almost unlimited authority, as the guardian of the idea of National Socialism. To the Senate, the party leader is responsible for ensuring that he, like every other party member, also subordinates himself to the idea and the party. The Senate comprises a total of 64 senators (Grand Senate), 24 of whom form a kind of working committee (Small Senate).

The senators must meet the highest requirements in terms of their ideological conviction and steadfastness, their selflessness and impartiality in the face of internal party disputes, their loyalty to the party, their honesty and their unrestricted reputation among party comrades. At the time of their appointment they must no longer be in active struggle, i.e. they must not be entangled in interests, struggles and all the trivialities of day-to-day organizational work.

A senator is appointed for life by unanimous vote of the Senate (the party leader has veto power) and can also be expelled from the Senate if unworthy, only by unanimous vote of all other senators. As a community - i.e. with unanimous decisions - the Senate has extraordinary powers:

The Senate elects the party leader. It alone can also dismiss a party leader. It has the right to veto all decisions of the party leadership and can itself issue orders to the party, although the party leader then has a veto right. As a rule, however, the Senate will confine itself to advising the party leadership and will intervene only when principles are in danger. After the party seizes power, the Senate's powers apply *mutatis mutandis* to all levels of the emerging National Socialist Volksstaat (see State), as they do in the New Order.

Under the current conditions of the second period of struggle in Germany, the Senate is formed as soon as the re-establishment of the National Socialist German Workers' Party is completed. The party leader appoints the first 24 senators, although the senators already in office can each prevent a new appointment by veto as a community. Upon reaching the number of 24 senators, the National Socialist Senate is constituted with all powers, thus fulfilling the wish of the Führer Adolf Hitler:

"Through it a number of the oldest, most loyal, and most capable heads of the movement are to be brought into direct connection with the supreme party leadership. To belong to this Grand Senate of the Movement shall in the future be felt and regarded as the greatest honor of the Movement."

115 - SLAVES

The Slavs are, along with the Germanic, Romanic and East Indo-European peoples, one of the families of peoples of the Aryan race (see Aryans) and settled in Europe mainly in the east of the continent. The Slavs belong racially to the Eastern racial type of Aryanism. Their core people - at the same time the ethnic carrier of the Soviet empire (see also Soviet Union) - are the Russians.

Historically, the Slavs are heirs of the Eastern Roman Empire of Byzantium and creators and shapers of Pan-Slavism. Both belong to the foundation of a future Slavic National Socialism, whose post-political task is the liberation of Eastern Europe from Marxism and the Soviet dictatorship as well as the integration into the coming Fourth Reich - the European Greater Spatial Order of National Socialism.

Within this empire, National Socialism guarantees all Slavic peoples the preservation and development of their species in their historical habitat and realizes the goal of Pan-Slavism for the unity of all Slavic peoples in a Slavic Federation. Of course, National Socialism takes away from this Pan-Slavism its historical front position against the Germanic peoples and especially against Germany, since it guarantees all Aryan peoples equally preservation of species and development of species and thus secures the future of the Aryan race as a whole.

Although National Socialism originally addressed itself exclusively to the Nordic-Germanic type of man, the present plight of the whole White Race forces it now to



conceive of itself as the organized will to life of the race as a whole. The bearer of this will, also in the Slavic peoples, is the National Socialist world movement with its respective National Socialist parties, as it is for Germany the National Socialist German Workers' Party.

Thus, the National Socialism of the new generation in the future also secures the preservation and development of the species of the Eastern racial type in its struggle for the survival and the higher development of the whole Aryan race in accordance with the species and nature. The prerequisite for this is the liberation of the Slavic peoples through the overthrow and collapse of the Soviet Empire. This liberation can take place in the atomic age only from the inside.

This long-term perspective does not, therefore, prevent the national German Ostpolitik, advocated by the Gesinnungsgemeinschaft der Neuen Front, which seeks first to restore German unity, freedom and sovereignty through negotiations with the Soviet empire, while striving for the foreign policy neutrality of the German state, independent of West and East.
